Fishing Guide License Information and Requirements:

Beginning July 31, 2010, an annual fishing guide license is required for residents and non-residents who assist, accompany, or transport, guide or aid persons in the taking of fish for commercial purposes. A fishing guide license does not exempt the license holder from an Oklahoma Fishing License. The fishing guide license must be with you or on your person. Licenses can be obtained via mail, online or in person at ODWC Headquarters.

Exemptions include:

- 1) Landowners or agriculture lessees who provide such services on properties they own or lease.
- 2) Persons assisting the licensed guide in the same vessel.

Instructions for Required Affidavit:

All natural persons applying for a commercial license from the Oklahoma Department of Wildlife Conservation ("Department") are required, by the provisions of 56 O.S. Supp. 2007 § 71, to provide the Department with verification of lawful presence in the United States by executing the Affidavit below before a notary public or other officer authorized to notarize affidavits under State law. If submitting your license application by mail, this form must be signed, notarized and returned with your application before a license can be issued. The Department's main office in Oklahoma City is staffed with notaries who will provide notary service at no cost to Applicants who appear **in person**.
