Scope of Work

Services – Mowing/Brush Hog

Copan Wildlife Management Area, Washington County, Oklahoma

1. General Requirements

The proposed contract is for mowing of approximately 18 miles of roads, 5 miles of dikes and 7 acres of grass. Mowing/brush hogging will need to be done three times. **First mowing time**, the week of May 1, 2025, **second mowing time** week of June 1, 2025, and **third mowing time** June 30, 2025. Mowing will be done on the Copan Wildlife Management Area in Washington County in northeast Oklahoma (see attached map).

Minimum Equipment Requirement: The equipment to be used must meet the following minimum specifications: The mower/brush hog must have a minimum width of 15 feet.

Vendor is to provide all labor and needed equipment to complete the work as required. Operator will not be compensated for time spent on maintenance and repairs of equipment. Project must be completed by June 30, 2024. All work will be done as directed by the ODWC Area Biologist including dates and start time.

Contract will be awarded to one vendor only. If the vendor is awarded multiple ODWC projects, they must be capable of completing each project simultaneously.

Bids are invited as stated on the solicitation cover sheet and must be returned by date and time specified. Late bids will not be considered.

Insurance: The successful bidder will be required to provide certificates of insurance for general liability, vehicles, and work compensation. A contract will not be issued without the required proof of insurance.

Basis of Contract: The determination of the Lowest Responsible Bidder will be made based on the lowest extended price (# of miles X price) and (# of acres X price). Failure to submit a complete bid, inclusive of requested information may disqualify the bidder. ODWC reserves the right to make any inquiries to ensure that the lowest bidder can complete the work in a satisfactory manner.

The contract will be issued by the Office of Management and Enterprise Services, Construction and Properties Division (OMES/CAP). **The contractor shall not begin work until the contract is in place and written notice to proceed has been issued by OMES/CAP.**

Terms and Conditions: As stated in the contract.
