

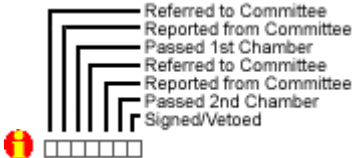

Removes Affirmative Action Requirements from the Wildlife Conservation Commission, removes power of the Director to make

complaints and cause proceedings against persons.

Permits the use of air bows during certain hunting seasons and for the killing of nuisance wildlife and feral swine.

Removes licensing requirements for night hunting of certain animals except on public property.

Creates the Oklahoma Hunters First Act, requiring a certain percentage of tags issued by the Wildlife Conservation Commission for specific game to go to Oklahoma residents each year.

Adjusts certain hunting and fishing license fees, exemptions based on age, and requires the Wildlife Conservation Commission to report each five years on licensing fees in relation to the Consumer Price Index; EMERGENCY.

Creates the Invasive Species Task Force to study and make recommendations of appropriate measures to combat and slow the spread of invasive species, details composition, and report requirements.
