• The 2024 sales surge before the price increases impact this comparison. A comparison of June 2023 vs. June 2025 shows 300 fewer licenses sold this year with a revenue decrease of about \$80,000.

#### **Information Technology**

- IT took in a total of 38 tickets this month. This is a record low.
- Laptop Deployments: ODWC has roughly 120 laptops whose leases will lapse by the end of the year. We have identified the users and have scheduled replacements for them in 4 groups.
- Oklahoma Room AV Workflow Modifications: After our first commission meeting with the new AV system, the AV team identified a few pain points and found ways to mitigate them going forward.
- Axon Body Cam Roll Out: We worked with Law Enforcement to assist in switching from their old body cams to the new Axon System.

- Cellphone Roll Out: We are working with Law Enforcement to schedule cellphone deployments for 78 new phones.
- Lease Inventory System: Development continues on a new lease inventory system to track computer hardware more efficiently.
- Shotgun in the School Program: A major rewrite of the "Shotgun in the School" program is underway in preparation for the upcoming season. This is a long-term effort aimed at improving functionality and maintainability.

# **Property**

- Deployed final FY25 Warden truck, and started process of preparing turn-in Warden trucks for next vehicle auction.
- Concluded July 2025 Vehicle Auction, all vehicles have been picked up by buyers.
- Completed daily routine checks of central office building grounds and equipment. Made minor repairs as needed.
- Conducted normal mailroom and building/grounds maintenance activities. 814 pieces of mail were sent out in the month of July in the mailroom.

#### Meeting

- Meeting with FlowCam for plankton identification and algae counting.
- All fisheries technicians attended the fisheries division technician meeting at Murray Lake State Park.

#### Activity

- Began writing up bird predation and soil/water quality studies.
- Helped with dam draining at Sardis Lake and the moving of fish and collection of drum for mussel propagation.
- Pond bank reshaping and erosion control were completed on two ponds. A washedout water drain culvert was repaired following excessive rainfall. A new dishwasher was installed, and office renovations were completed. Additionally, residence #2's HVAC unit was serviced and repaired.
- At the Durant Hatchery, a rotted tree in the park area was felled. Ponds in phases 0, 1, and 2 were rotovated, and Variable Frequency Drives (VFDs) were installed in the river pump station. At the Holdenville Hatchery, the fish hatching building was repaired, and the wood shop was cleaned out in preparation for painting.
- A goldfish forage pond was set up, cleaned, sprayed, and stocked with broodstock. At the Durant Hatchery, 1,200 lbs of forage were added to the brood Florida

- Largemouth Bass (FLMB). Technicians picked up channel catfish fry from the Tishomingo Federal Hatchery and transported sunfish to Elk City for a fishing derby.
- At Holdenville Hatchery, two loads of Rainbow Trout were transported and distributed to the Lower Mountain Fork River, and staff assisted with fish habitat projects. Fish were fed daily and as needed across all hatcheries, and water quality was regularly monitored.
- Progress on the Lake Watonga dam was slow in July. Final grade on the dam was completed with topsoil. Riprap and gravel were hauled to the site.
- Maintenance work on department lakes continues. Activities include mowing at American Horse and twice at Elmer, and herbicide applications to maintain fishing access on department lake areas and trash pick-up.
- Staff met with State Parks at Watonga to discuss potential repairs for the Boecher dam. State Parks has hired an engineer to investigate options. It is unknown at this time what the impacts on Lake Watonga will be.
- Staff scouted the Canadian drainage for plains minnows in attempt to provide Colorado with broodstock. No Plains Minnows were found.
- Broodstock silversides, bluegill, redear sunfish, and gizzard shad were collected and stocked into Jap Beaver Lake to support forage base enhancement. Fire guards at Jap Beaver Lake were maintained, and general upkeep at department-managed lakes was completed, including mowing, weed-eating, trash pickup, and herbicide application.
- A meeting was held with the Oklahoma Water Resources Board (OWRB) for the inspection of Jap Beaver Dam.
- Staff assisted the Wichita Mountains National Wildlife Refuge (WMNWR) with an electrofishing survey to assess local fish populations.
- An aquarium display was transported to Fort Sill for a kids' fishing event, helping promote youth engagement in aquatic education and angling.
- Biologists continued statewide work on Letters of Authorization (LOAs) and scientific collector permits to support regulated fish and wildlife research activities.
- The Sooner Creel Survey continued.
  - 1. 314 in person interviews have taken place from Sept 1 July 31. (51 the month of July)
  - 2. 62 creel days have been completed from Sept 1 July 31. (7 Creels in the month of July)
  - 3. 126 surveys were turned in from QR Codes from Sept 1 July 31. (26 surveys in the month of July)
- Threadfin shad production continued in the Skiatook Nursery Pond. Biweekly monitoring has shown reproduction. Fry were 35 mm average length in the July samples. Aquashade was applied to increase turbidity and deter plant growth.
- Boating Access Inspections were completed for the region.
- NCR staff assisted NER staff with Blue Catfish sampling on Oologah and Flathead Catfish sampling on Grand.
- Shelbyville Cube components were assembled for future deployment in Skiatook and Kaw reservoirs.
- The PNNG crew completed the fabrication of a new electrofishing boat for nongame collections. This is actually an old boat that the crew resourcefully repurposed to serve as an electrofishing boat.

- Reviewed applicants and interviewed to fill the Paddlefish and Native Nongame Technician vacancy.
- Assisted in the rescue of entrapped fish in Oologah spillway.
- PNNG staff continued to cut, photograph, and age Smallmouth Buffalo otoliths from bowfishing tournament salvages and Shell Lake sampling.
- PNNG staff participated in ongoing meetings with the Mississippi Interstate Cooperative Resource Association (MICRA) on developing a range-wide management framework plan for Paddlefish.
- PNNG biologist continued development of a paper on the fishing guide industry with Oklahoma as a case study.
- Completed efforts for revising the Oklahoma Fishing and Hunting Regulations booklet for 2025-2026.
- Supervisor attended the appraisal of the building proposed for purchase in Stillwater for new regional office and continued to act as liaison between the seller and the department.
- Staff continued planning activities for the 2025 OKAFS meeting in Jenks as members of the ExCom.
- Staff continued tagging flathead catfish on Grand Lake to look closer at spawning site fidelity, movements, and harvest. A social media post was made informing anglers of the project and the importance of notifying us of any tagged flatheads they catch. The post was extremely popular on Facebook with mostly positive feedback, which highlights the possible need for including Flathead Catfish (native to Oklahoma waters) as a Game Fish. Thus far, over 200 flatheads have been tagged, with over 20 recaptures, and 4 angler recaptures (1 harvest, 3 released). The majority of ODWC recaptures are in the same general vicinity they were tagged, with 1 moving half a mile in a week, and another moving 1 ¼ miles in a year.
- Staff conducted blue catfish electrofishing on Oologah Lake with assistance from ANS, East Central Region, Native Non-game, and North Central Region crews. A total of 578 blue catfish were collected during the survey, and 370 pairs of otoliths were removed for age and growth analysis. These types of surveys are great to see and take part in as ODWC fisheries personnel from neighboring regions collaborate.
- Staff removed stranded fish from below the Oologah dam spillway with the assistance of USACE. Hundreds of game and sport fish were collected from below the spillway and taken back to the lake.
- Staff continued planning and communications for the upcoming annual OKAFS meeting. NER personnel involved with communications as OKAFS president, OKAFS nominations and awards committee chair, and OKAFS student concerns committee chair.







- Prepared presentations for AFS and streams meetings
- Conducted cooperative fish rescue with COE and Choctaw Nation below Sardis dam, when the area below the dam was dewatered for inspection/repair. Several thousand juvenile blue and channel catfish were moved, but there were very few other fish present (other than gizzard shad). The fish rescue/removal was very thorough and only a minimal number of fish were lost during the dewatering. Almost all the mortalities were shad and were caused by handling stress.
- Grounds maintenance at PFA's and offices.
- Creel survey at Wister.
- Continued with community sampling, primarily in the Poteau River drainage.
   Noteworthy collections included Blackside and Harlequin Darters, and Lamprey ammocoets.
- Staff prepared three talks and three posters for the National AFS meeting in San Antonio, Texas. Staff assisted with the preparation of an additional three posters and one talk for other analysis and preparation of materials for the National AFS meeting.
- Staff continued Channel Catfish Spawning box checks spawning box and recruitment study. Staff sampled Channel Catfish in Close to home ponds.
- Staff continued deployment of habitat in Lake Eufaula and began construction of reef balls (a new artificial habitat type) for deployment.
- Analysis and writing for country wide Smallmouth growth rates (Texas Parks and Wildlife, Kansas Department of Wildlife and Parks) continues.
- Preliminary data for Flathead Catfish power threshold assessment at OFRL in conjunction with ETS electrofishing Systems, LLC was collected.
- Multiple meetings with local resource partners, elected officials, and constituents regarding boating access potential at Lake Texoma.

- Staff completed 2023/2024 bass tournament reporting summary, prepared a draft report for public consumption, and prepared a presentation for upcoming AFS meeting.
- collected vertical water quality profiles at Lake Texoma, made graphics, and provided constituent updates (via Facebook).
- Made roadway and stocking road culvert improvements at Blue River.
- Hauled stockpile gravel to BR for upcoming projects.
- Assisted multiple landowners w/ technical assistance private ponds.
- Discuss fisheries management issues and regulations w/ Tishomingo National Refuge manager.
- Continued the creel survey project on Greenleaf Lake, conducting five additional interviews and two pressure counts over one day in July, for a total of 207 interviews for the survey to date.
- Placed multiple Shelbyville Cubes into Greenleaf Lake as fish habitat enhancement and refurbishment.
- Built over 30 Shelbyville Cubes to be placed in area lakes to enhance and refurbish fish habitat.
- Reviewed environmental review requests and drafted and submitted responses related to projects that could impact fish and wildlife resources across the state.
- Reviewed and compiled compliance documents for a new shop building to be constructed at Durant State Fish Hatchery.
- Continued Skipjack collections for species specific research.
- Hauled two trout stockings from the Norfork National Fish Hatchery and stocked in the Lower Illinois River
- Placed temperature loggers in Lower Illinois River at 4 locations along the gradient of the river.
- Maintained stocking roads along spillway creek at Lower Mtn Fork River.
- Attended USACE/SWPA/ODWC stakeholder meetings concerning Lower Illinois River conditions and ongoing hydropower outage.
- Technician meeting attendance and participation from all Porter program and regional staff.
- Attended final Leadership Development level 2 meeting and submitted final report for review.
- Assisted NER with Oologah bluecat electrofishing survey.
- Responded to numerous black carp calls and inquiries including interviews with news outlets.
- Finalized ANS preproposal phase 1for submittal, awaiting Notice of Funding Opportunity.
- R.S. Kerr hydrilla spot check and attempted mapping, conditions not conducive to date.
- Reviewed and catalogued zebra mussel veliger sampling reports from Bureau of Reclamation, with no positive samples collected.
- Continued larval light trapping on Grand lake to detect bighead carp reproduction.
- Collected 66 eDNA samples on the Lower Arkansas river from L&D 15 to the state line and 6 eDNA samples on the Lower Red river.
- Routine building and grounds maintenance at Porter office, Echota, Stunkard, Bamberger and Watts properties.

- During the meeting we also issued the MIFIs and Rolling gave us a tutorial on how to operate them and how to get our BWCs to link up. She did an outstanding job of making it understandable.
- Wardens Jackson and Jenks attended the NAWEOA Conference in Erie, PA. They attended numerous training sessions including Black Bear Conflict Management, Surviving Critical Incidents, and others.
- Warden Jackson attended Adaptive Challenges training as part of the Leadership Development Training Program.
- Wardens Jackson, Jenks, Moore, Morris, Willman, Rolling, and Lt. Alexander worked a special emphasis on the small creeks in Delaware County. They are having continued complaints of folks catching WAY over the limit on various species of small creek fish. The favored technique is cast netting which is still legal in all areas EXCEPT the Scenic Rivers but the limit is 25 fish. They implemented two undercover vehicles and posed as fisherman to access areas discretely. Although they made no arrests, they were able to work areas that are very hard to get to in uniform. This may be repeated as needed to address the problem.
- Wardens Mooris, Tilley, Rolling, and Lt. Alexander attended the Quail Forever Youth Day and assisted with STEP and Archery located at the Strang Park.
- Warden Tilley assisted the Fisheries Division with electrofishing on Oologah Lake.
- Warden Willman assisted the Fisheries Division with a flathead catfish survey on Grand Lake. Willman was able to glean a ton of practical information on how to address LE issues with illegal noodling all while assisting the Fisheries Division in their Flathead Study.
- Lt. Alexander attended a meeting with all stakeholders, including contractors, ODWC personnel, USACE, and neighboring landowners for the new shooting range being built on Copan WMA. Construction to begin on Aug.1st
- Warden Jerermy Bersche and Lt Welch responded to a complaint of possible illegal netting on Bird Creek near Pawhuska. The suspects were from a nearby marijuana grow operation. Bersche and Welch were able to gain access covertly to the creek and their timing was perfect. A subject from the operation ran the nets as they were hiding nearby. Bersche was able to obtain a warrant for the residence. On August 7, Jeremy Bersche, Jake Bersche, Rolling, Tilley, Grace, Green, and Jenks executed the warrant along with the Osage Co SO and members of the Oklahoma AGs office and OMMA. Numerous fish and fish parts were seized from the residence along with several nets, boats, and fishing supplies. OMMA collected almost 160# of illegal, untagged, sealed marijuana along with a host of other violations.
- Hunter Education Courses began at Owasso on Aug 13 and continue throughout the fall.

- During this period, Wardens James and Thomas Gillham patrolled Honobia Creek WMA and contacted 19 different individuals and issued 6 citations in for failure to have a land access permit.
- Wardens Thomas Gillham and Blake Dull are continuing a bear poaching investigation where they have been able to secure a search warrant for a GPS tracking device to be placed on a suspect's vehicle.
- PGW Chance Phillips is in Phase 3 of the Field Training Program, he has focused on patrolling the trout stream and issued 35 citations (ADF's, Temporaries and warnings) from 312 compliance checks which computes to 11% non-compliance. He

- also assisted Three Rivers/Honobia Creek/ Herron WMA biologist Sid Tabor with sign placement on the new Herron Family WMA.
- PGW Blake Dull is also in Phase 3 of the Field Training Program, and he is progressing very well.
- Lt. Lawson is investigating a horseback trail riding business which is using Three Rivers WMA as a place to ride. None of the participants in the business or any of their customers have had land access permits and the owners are operating a concession on ODWC managed land without written permission from the Director.

- Wardens are set to attend the 2nd Annual Racks and Rods Outdoor show in Woodward Aug 22, 23, and 24 with the new Law Enforcement 10x10 Booth.

# Investigations/Training - Capt. Loftis WILDLIFE INVESTIGATIONS SPECIALIST/WILDLIFE INVESTIGATION TEAM (WIT)

- Inv Long was deployed by USFWS/OLE on an ESF13 disaster detail to the Texas Floods (Kerr County) as Force Protection for Missouri Task Force One for twelve days.
- Inv Long attended the 2025 AFWA Investigations and Intelligence Summit in Clearwater Beach, Florida.
- The Reptile and Amphibian WIT members convened in person at the ODWC headquarters to discuss potential regulatory changes. They collaborated with Wildlife Senior Biologist Mark Howery to evaluate these matters from both legal and biological perspectives, with a focus on population size, density, and other factors affecting native reptile and amphibian species.
- Inv Long taught Defensive Tactics in District 8 in Enid.
- GW Rolling has had five (5) investigations involving charges and violations related to non-commercial breeder licenses, offer for sale, illegal possession of wildlife, and illegal importation into the state. The wild animals involved in these cases included a red fox, red-eared sliders, raccoons, skunks, and opossums. These animals were either seized or willfully abandoned to the Agency. GW Rolling had assistance on these cases from wardens throughout the NE region, including GW Jackson, GW Stauffer, and GW Wagner.

# **FTO Program**

- The fifth cohort of the Game Warden Academy is currently progressing through the Field Training Officer (FTO) program. Of the seven Probationary Game Wardens (PGWs), five have successfully advanced beyond Phase 2, which concludes the initial eight-week training period. Phase 3 requires PGWs to demonstrate the ability to operate independently for the majority of their duties and exhibit proficiency across core game warden competencies.
- Two PGWs did not meet the required standards to transition into Phase 3 and were assigned the maximum allowable four-week period for remedial training. One PGW voluntarily resigned during the third week of remedial training after it was determined that he was not responding to training (NRT), would not meet program expectations and should be removed from the program. The second PGW has entered the fourth week of remedial training; however, concerns remain regarding his overall competence and mental fortitude for the demands of the role. A final determination regarding his status in the program is forthcoming.
- The remaining five PGWs are performing exceptionally well. They have received commendations from their FTOs for their professionalism, motivation, skill proficiency, and resilience. The Law Enforcement Division continues to express support for the Academy and FTO program structure, which emphasizes standardized training principles and accountability.
- Together, these programs have demonstrated their effectiveness in identifying and cultivating high-performing candidates while ensuring that individuals who do not meet the rigorous standards are appropriately evaluated and addressed. This has

improved morale in the field over this aspect of the hiring process, because, this approach has significantly reduced the risk of underqualified personnel entering the field, thereby enhancing the overall integrity and operational readiness of the department.
